2018 has been a successful year for our club.

We started 2018 with 44 members and had 19 new members join throughout the year. At 31st Dec we had 58 members, and to date we have 61 members, welcoming seven new members in January. Our membership now consists of, 9 Family Memberships (18 members), 40 single memberships and 3 Life Members.

Our outings were well attended again this year, and thank you to everyone for your assistance on the day. It is a great way to meet your fellow members, and from time to time, finish with a BBQ.
